Most important symptoms and effects, both acute and delayed:

Headache, Shortness of breath. Causes gastrointestinal irritation with nausea, vomiting and diarrhea. May cause blood abnormalities. May cause bloody stools and vomit, low blood pressure, jaundice and coma. Irritation/burns, all routes of exposure. Dust is irritating to the respiratory tract and cause pain, burns, and inflammation. May cause liver and kidney damage. May cause bromism characterized by disturbances of the central nervous system, skin and digestive tract. and kidney damage;

Extinguishing media

Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors.

Advice for firefighters:

Protective equipment: Use NIOSH-approved respiratory protection/breathing apparatus.

Additional information (precautions): Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.
